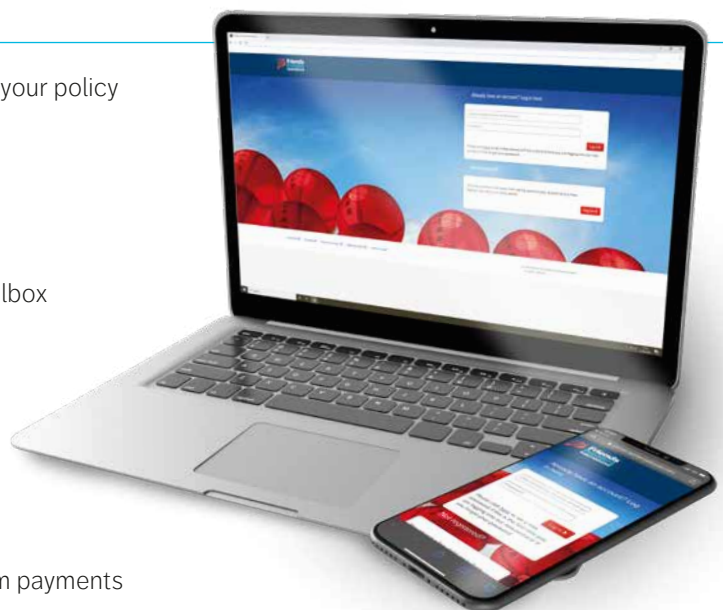

### Alterations

for change of agents/address/beneficiary/ assignments etc use **L#S1** (policy number of more than six digits) **B#S1** (six digit or less)

### Premiums

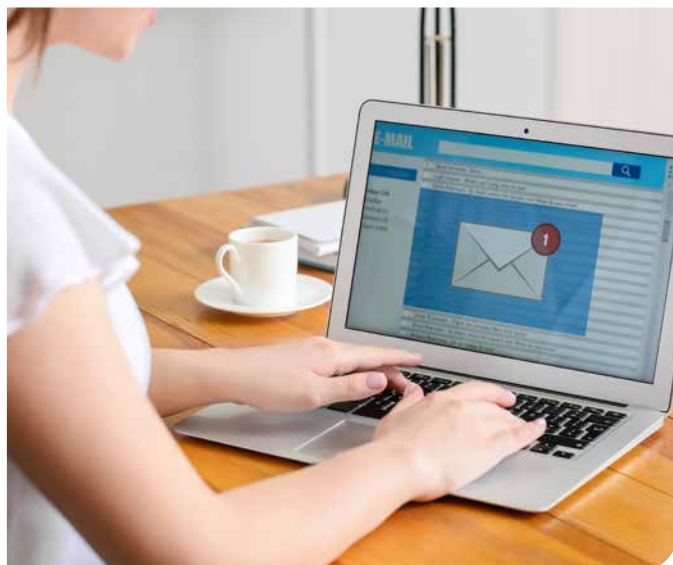
for premium enquiries, reinstatements etc use **P#R1**

### Cash

for withdrawals and surrenders use **L#C1** (policy numbers of more than six digits) or email [bondclaims@fpiom.com](mailto:bondclaims@fpiom.com) (six digit policy numbers or less)

### General queries

General queries should just be sent to [customerservices@fpiom.com](mailto:customerservices@fpiom.com) with no prefix
