Dear Shareholder,

We are writing to advise you of the following changes to certain funds of Fidelity Funds (each a "Sub-Fund", and collectively, the "Sub-Funds").

Any terms not defined herein shall have the same meaning as in the prospectus of Fidelity Funds, the Hong Kong covering document and the Product Key Facts Statements of the Sub-Funds (collectively the "Hong Kong Offering Documents").

Description of the Changes

We have decided to change the name of the following Sub-Funds:

- Fidelity Funds Sustainable Euro Cash Fund, will be re-named Fidelity Funds Euro Cash Fund;
 and
- 2) Fidelity Funds Sustainable US Dollar Cash Fund, will be re-named Fidelity Funds US Dollar Cash Fund.

These name changes reflect the evolution of the application of regulation relating to the promotion of mutual funds and sustainable investments. For the avoidance of doubt, all other features of the Sub-Funds, and the manner in which the Sub-Funds are being managed in practice, remain unchanged. There will also be no change to the Chinese names of the Sub-Funds.

Costs

Any administrative expenses triggered by the changes (including any legal, audit, mailing and regulatory charges) will be borne by FIL Fund Management Limited, the Investment Manager of Fidelity Funds (and/or any of its affiliates within the FIL Group).

Effective Date

The above changes will take effect on 11 April 2023 and will be reflected in the next update to the Hong Kong Offering Documents.

The Board accepts full responsibility for the accuracy of the information contained in this letter and confirms, having made all reasonable enquiries, that to the best of its knowledge and belief, there are no other facts the omission of which would make any statement herein misleading.

我們特此致函通知閣下有關若干富達基金(各自稱為「子基金」及統稱為「該等子基金」)的變動。

本函件未有定義的任何特定詞彙,具有與富達基金認購章程、香港説明文件及該等子基金的產品資料概要(統稱「**香港發行文件**」)中所載相同的涵義。

變動說明

我們決定更改以下子基金的英文名稱:

- 1) Fidelity Funds Sustainable Euro Cash Fund 將更名為 Fidelity Funds Euro Cash Fund;及
- 2) Fidelity Funds Sustainable US Dollar Cash Fund 將更名為 Fidelity Funds US Dollar Cash Fund。

以上名稱更改反映與推廣互惠基金和可持續投資相關的規例應用的發展。為免生疑問,該等子基金的所有其他特點,以及該等子基金的實際管理方式維持不變。該等子基金的中文名稱亦將維持不變。

費用

變動所涉及的任何行政開支(包括任何法律、審核、郵遞及監管開支)將由富達基金的投資經理 FIL Fund Management Limited(及 / 或其在富達集團內的任何聯營公司)承擔。

生效日期

上述變動將於 2023 年 4 月 11 日生效,香港發行文件將於下一次更新時反映上述變動。
